

**THE HALLMARK CHRISTMAS EXPERIENCE FROM HALLMARK GOLD CROWN
SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

SWEEPSTAKES ENTRY PERIOD: The Hallmark Christmas Experience from Hallmark Gold Crown Sweepstakes (the "Sweepstakes") begins at 12:00:01 AM Eastern Time ("ET") on Monday, September 22, 2025 and ends at 11:59:59 PM ET on Monday, October 27, 2025 (the "Sweepstakes Period").

ELIGIBILITY: The Sweepstakes is open to legal residents of the 50 United States, including the District of Columbia and legal residents of Canada (excluding Quebec), who are age 21 or older and have a Crown Rewards account (U.S. residents) or a Hallmark Rewards account (Canadian residents) in good standing at the time of entry. Crown Rewards and Hallmark Rewards accounts collectively referred to herein as "Rewards Account" or "Rewards Accounts". The email address provided with any Entry must match the email address associated with entrant's Rewards Account. Void in Quebec, Puerto Rico, Guam, the U.S. Virgin Islands and wherever else prohibited by law. Employees of Hallmark Cards, Inc. and William E. Coultts Company, Limited/La Compagnie William E. Coultts, Limitee (DBA Hallmark Canada) (the "Sponsors"), US Sweepstakes & Fulfillment Company (the "Sweepstakes Administrator") and their respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter. Method #2: Hallmark Card Entry. To participate using the Hallmark Card Entry method, participants must purchase a Hallmark brand greeting card at any Hallmark Gold Crown location in Canada or the U.S., any Hallmark Gold Crown store inside select Canadian Pharmacies, Drugstores and Drug Marts participating in the Hallmark Rewards program, or Hallmark.com in the US, during the Sweepstakes Period (the "Eligible Purchase") and take a photograph of the Eligible Purchase receipt with the Hallmark brand greeting card circled (the "Receipt Photo"). To enter, during the Sweepstakes Period and upon completing a Registration Entry, follow the instructions

on the Registration Entry confirmation screen or return to the Website and use the returning user login and upload and submit a Receipt Photo to receive one (1) additional entry into the Sweepstakes (the "Hallmark Card Entry"). In the event there are multiple Hallmark brand greeting cards purchased during a single Eligible Purchase, Receipt Photo may be uploaded once for each card in the Eligible Purchase. Eligible Purchases and Receipt Photos may not be shared by multiple participants. **Limit: Ten (10) Hallmark Card Entries per person during the Sweepstakes Period.**

Method #3: Free, Alternate Method of Entry ("AMOE") / Mail-in Entry. To enter without making an Eligible Purchase, clearly hand-print your name, complete address, email address associated with your Rewards Account and phone number on a sheet of paper and mail that sheet of paper in an addressed envelope with proper postage to the following address (the "Mail-In Entry") to receive one (1) entry into the Sweepstakes:

Each Mail-In Entry must be mailed separately and must be postmarked between Monday, September 22, 2025 and Monday, October 27, 2025, and received by Monday, November 3, 2025. Photocopied, illegible, or mechanically reproduced entries are not eligible. All entries become the property of the Sponsors and will not be returned or acknowledged. Sponsors are not responsible for lost, late, damaged, misdirected or postage-due mailed entries. **Limit: Ten (10) Mail-In Entries per person during the Sweepstakes Period.**

Entrants are subject to all notices posted online including but not limited to the Sponsors' Privacy Policies, which can be found at <https://www.hallmark.com/privacy/> and <https://www.hallmark.ca/en/privacy/>.

Registration Entry, Hallmark Card Entry and Mail-In Entry collectively referred to herein as "Entry" or "Entries". **Limit: Eleven (11) Entries per person regardless of method of entry.** All methods of entry have an equal chance of winning. All entries become the property of the Sponsors and will not be acknowledged or returned.

PRIZE/APPROXIMATE RETAIL VALUE ("ARV")/ODDS:

Grand Prize: There is one (1) Grand Prize available to be won. Grand Prize consists of a Holiday getaway for two (2), winner and one (1) guest, to Kansas City, MO to attend the Hallmark Christmas Experience from 12/12/25 to 12/14/25. Prize package will include:

Odds of winning will depend upon the total number of eligible entries received.

RANDOM DRAWING: The potential winner will be selected in a random drawing on or about **11:00 AM ET on Thursday, November 6, 2025** from among all eligible entries received during the Sweepstakes Period by the Sweepstakes Administrator, an independent representative of the Sponsors whose decisions are final.

WINNER NOTIFICATION & VERIFICATION: Potential Grand Prize winner will be notified via email and/or phone, and will be required to sign and return, within five (5) days of notification, an Affidavit of Eligibility, a Liability Waiver, an IRS W-9 Form and where allowable, a Publicity Release (collectively, "the Releases") or, if winner resides in Canada, a Declaration and Release Form (the "Declaration"). If Sponsors are unable to determine

Sponsors may ask any entrant or potential winner to provide Sponsors with proof, to Sponsors' satisfaction, that such party

is the authorized account holder of the email address associated with the entry. Entry materials/data that have been tampered with or altered, or mass entries or entries generated by a script, macro or use of automated devices are void. The Released Parties are not responsible for: (i) lost, late, misdirected, damaged or illegible entries; or (ii) error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry information by Sponsors on account of technical problems or traffic congestion on the Internet or at any web site or any combination thereof; or (iii) any injury or damage to entrant's or any other person's computer related to or resulting from participating in the Sweepstakes. By participating in the Sweepstakes, entrant (i) agrees to be bound by these official rules, including all eligibility requirements, and (ii) agrees to be bound by the decisions of Sponsors and the Sweepstakes Administrator, which are final and binding in all matters relating to the Sweepstakes. FURTHER, SPONSORS SHALL NOT BE RESPONSIBLE FOR ANY CANCELLATIONS, DELAYS, DIVERSIONS, CHANGES IN SERVICE OR ACCOMMODATIONS OR SUBSTITUTIONS, OR FOR ANY ACTS OR OMISSIONS BY ANY THIRD PARTIES BEYOND ITS REASONABLE CONTROL, INCLUDING AIR CARRIER(S) AND OTHER TRANSPORTATION COMPANIES; LODGING, RESTAURANT OR OTHER HOSPITALITY PROVIDERS; ENTERTAINMENT PROVIDERS, VENUES OR ARTISTS; OR OTHER THIRD PARTY PROVIDERS SUPPLYING ANY SERVICES OR COMPONENTS OF THE PRIZE(S) TO WINNERS AND/OR THEIR GUESTS, OR FOR ANY RESULTING INJURIES, INCLUDING MONEY DAMAGES, COSTS AND

EXPENSES, PROPERTY DAMAGES, PERSONAL INJURIES OR DEATH RESULTING THEREFROM.

GOVERNING LAW AND LIMITATION OF LIABILITY: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants, Sponsors or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of Montana, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.

SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

DISPUTES: The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the state, provincial and federal courts in Jackson County, MO and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-

person hearing is required, then it will take place in Kansas City, MO. The federal or state/provincial law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in Kansas City, MO. Sponsors agree to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.

PRIVACY: As a condition of entering the Sweepstakes, each entrant gives consent for Sponsors to obtain and deliver their name, address and other information to third parties, including Sweepstakes Administrator, for the purpose of administering this Sweepstakes and to comply with applicable laws, regulations and rules, including, without limitation, the storing of your personal information for purposes of complying with state/provincial record retention requirements.
